## Application for Aerial Control Use Permit

The State of Utah, Department of Agriculture ("Department") is responsible for the issuance of permits and licenses for the purposes of the Federal Fish and Wildlife Act of 1956. The Department issues these permits and licenses in coordination with the USDA-Wildlife Services. No state agency or private person shall use any aircraft for the prevention of damage from predatory animals without first obtaining a use permit from the Department. A state agency which contemplates the use of aircraft for the protection of agricultural crops, livestock, poultry, or wildlife shall file an application with the Department for an aircraft use permit to enable the agency to issue licenses to personnel within the agency charged with the responsibility to protect such resources. Additionally, persons who desire to use privately owned aircraft for the protection of land, water, crops, wildlife, or livestock shall not engage in any such protective activity without first obtaining an aircraft permit from the Department.

7. By signing this application, Applicant agrees that it shall be governed by the laws, rules, and regulations of the State of Utah. Any action or proceeding arising from this application or permit shall be brought in a court of competent jurisdiction in the State of Utah. Venue shall be in Salt Lake City, in the Third Judicial District Court for Salt Lake County.
8. Applicant also agrees that all activities performed under this application and permit shall comply with all applicable federal and state constitutions, laws, rules, codes, orders, and regulations, including applicable licensure and certification requirements.
9. Applicant shall be fully liable for the actions of its agents, employees, officers, partners, or named pilots under this application and pursuant to this permit and shall fully indemnify, defend, and save harmless the Department, including its agents and employees, and the State of Utah, from all claims, losses, suits, actions, damages, and costs of every name and description arising out of performance under this application and permit caused by any intentional act or negligence of Applicant, its agents, employees, officers, partners, or named pilots, without limitation, except as otherwise required under state or federal law.
10. Applicant further understands that this application and permit does not create any duties or obligations by the Department and the State of Utah, unless specifically required under state or federal law.
